## HPAI and COVID-19 Updates

## **Highly Pathogenic Avian Influenza**

On April 9th, the <u>United States Department of Agriculture (USDA) announced</u> the detection of a highly pathogenic Avian influenza (H7N3) in a commercial turkey flock in Chesterfield County, South Carolina. No human cases have been detected, and there is no immediate public health concern.

This is the first detection of HPAI in the US since 2017 and is believed to have mutated from low pathogenic H7N3 previously detected at commercial turkey facilities in North Carolina, near the South Carolina border. State animal health officials in both states and the USDA implemented standard response protocols including increased observational surveillance and disease testing in the area beginning in mid-March when the initial detection was made.

Rapid actions to limit the spread of disease were taken by the producer and State Animal Health Officials, with USDA support. The premises has been placed under quarantined and birds have been depopulated and will not enter the food chain.

This event is a good reminder that an industry can deal with multiple disasters at one time, in this case, COVID 19 and HPAI. All bird owners should continue to practice good biosecurity, prevent contact between their birds and wild birds, and report sick birds or unusual bird deaths to State/Federal officials, either through their state veterinarian or through USDA's toll-free number at 1-866-536-7593. ## **Tiger at Bronx Zoo Tests Positive for SARS-CoV-2**

On April 5th the <u>USDA announced</u> that SARs-CoV-2, the virus that causes COVID-19 in humans, had been confirmed in one tiger at the Bronx Zoo in New York. Samples from the female Malayan tiger were tested after multiple tigers and lions began showing signs of respiratory illness. The <u>Widlife Conservation Society</u> has reported that the tiger and all of the zoo's other cats are doing well at this time.

Naturally, this news has sparked a lot of questions within the zoological industry and
