# Is Your Facility Ready to Respond to a 'Disaster Within a Disaster'?

While the effects of the COVID-19 pandemic continue to challenge the exotic animal industry in many ways, we must not forget that other incidents or disasters may occur at this challenging time. North America is in the midst of hurricane season, and thunderstorms and other events are daily occurrences across the country. These incidents don't stop, just because we are responding to the coronavirus crisis. Is your facility ready to respond to a 'disaster within a disaster'?

Now is an ideal time to pull out your contingency plans and review them *completely* for any changes and updates that need to be made during this pandemic. Consider the following changes that facilities may need to consider:

- What is the current capacity for your storm shelters?
  - Are you able to practice social distancing within these shelters, even short term?
  - Is there a supply of PPE currently housed in the storm shelters for guests who may not have a mask?
- What are the implications for 'ride out' teams? For those individuals that are assigned to stay on site for longer term response periods, consider:
  - Are you able to reduce the number of employees that make up your teams
  - What adjustments in terms of cross training can be accomplished?
  - Have you lost valuable team members either through lay-offs, furloughs, or attrition?
    - Have you considered who would back fill those unique team positions?
  - Do your plans identify by name or job description, the roles one would play on a ride out team, and do those individuals or positions still exist within your organization?
  - If a team is housed on grounds, how can that be done safely?
    - Rather than group barracks type housing, can an office building be used to allow for proper social distancing and isolation of team members?
  - Will team members require any additional cleaning and disinfection training to operate safely at this time?

There are many challenges that the industry is facing at this time. It is recommended to review all aspects of your contingency plans and adjust accordingly just in case you experience a 'disaster within a disaster'.
