COVID-19 Zoological Facility Needs Assessment

Zoos, aquariums, sanctuaries, and like facilities continue to be heavily impacted by the ongoing response to COVID-19, causing significant financial losses and requiring facilities of all sizes to make significant operational and staffing changes. Zoological facilities continue to provide essential care for their animals despite these impacts however, as this event stretches on, financial constraints, shortages, supply chain issues, and other ripple effects could make it increasingly difficult for facilities to provide this care.

This needs assessment was developed to create a more complete picture of current and anticipated needs of the zoological community resulting from COVID-19. Aggregate data from this assessment will be used to inform ongoing response efforts, including advocacy for additional support for this community.

2020 Hurricane Season

NOAA recently released outlooks for the 2020 hurricane season, predicting a 60% chance of an above normal season in the Atlantic, and a 25% chance of an above normal season in the Central and Eastern Pacific:

- Atlantic
- Central Pacific
- Eastern Pacific

With many facilities already making significant operational changes in response to COVID-19, it is critical that those in hurricane prone areas review response plans to identify and work to address any gaps. Consider the following:

- How may staffing changes impact your facility's abiilty to carry out existing response plans?
 - Are all staff familiar with their roles, and able to carry them out under current conditions?
 - Do procedures for ride-out teams need to be adjusted due to COVID-19
- Do the vendors and MOU holders identified in your plan still have capacity to assist?
 - Have alternative vendors been identified if not?
- Are relevant contacts for emergency management and response partners up to date?
 - Do these partners have up to date contacts for your facility?
