#### Highly Pathogenic Avian Influenza (HPAI) Updates & Resources



As of February 24, 2022, the U.S. Department of Agriculture (USDA) has confirmed highly pathogenic avian influenza (HPAI) in twelve U.S. states, including New York, Indiana, Florida, and the Carolinas. This week, additional findings of HPAI were confirmed in both commercial and non-commercial flocks.
